The list below identifies some of the greedy "bottom feeders "who've slithered into "Kanehsatake", "Sharbot Lake", "Six Nations", "Dehcho" of NWT and elsewhere. It makes no attempt to identify those who are feeding from the many other Indigenous nations whose resources are being stolen by Canada and international corporate cartels.

One of the "head pirates" of this colonial pillage system is the Queen and her "aparatchnik", the Governor General. They throw the stolen bounty at their subjects. This creates an endless "feeding frenzy" among the bottom feeders and all the hangers-on, such as the public relations firms, media, all sorts of consultants, geologists, surveyors, miners, corporations, large and small time political hacks and all the "Eichmanns" who manage and facilitate this carnage.
